



# What is AVETMISS?

AVETMISS stands for the Australian Vocational Education and Training Management Information Statistical Standard. It is a national data standard which ensures the consistency and accuracy of vocational education and training (VET) information and covers three national data collections:

the National VET Provider Collection: release 8.0

the National Apprentice and Trainee Collection: release 7.0

the National Financial Data Collection: Standard available January 2021

### Why do I have to report AVETMISS data?

All registered training organisations (RTOs) need to collect and report AVETMISS data on all accredited training activity. This mandatory reporting is known as total VET activity (TVA) and supports more informed consumers. Details of TVA implementation, including any required transition arrangements, grace periods and exemptions are available on the <u>Australian Government Department of Employment and Workplace Relations</u> website at: https://www.dewr.gov.au/.

In April 2012, the Council of Australian Governments (COAG) agreed to implement the Unique Student Identifier (USI) so students could obtain a complete record of their vocational education and training (VET) enrolments and achievements from a single source.

The USI will enable students to collate their VET achievements into a single transcript and will ensure that their VET records are not lost if their training institution ceases to operate. Study completed prior to 2015 will not be included in the transcript.

The USI transcript will be populated with AVETMISS data submitted to NCVER from RTOs and State Training Authorities (STAs).

#### Under what authority is AVETMISS data collected?

As the AVETMISS custodian, NCVER collects AVETMISS information under the authority of the regulatory bodies for registered training organisations (RTOs).

# What privacy protocols apply to AVETMISS data submitted to NCVER?

NCVER complies with the Privacy Act 1988 (Commonwealth). NCVER's privacy policy describes how NCVER collects, manages, uses, discloses, protects, and disposes of personal information in accordance with the 13 Australian Privacy Principles (APPs) outlined in Schedule 1 of the Privacy Amendment (Enhancing Privacy Protection) Act 2012.

Access to the data held in the national VET administrative collections and surveys is governed by the VET Data Protocol. The VET Data Protocol sets out the principles and commitments for the storage and disclosure of VET information and aims to provide broad access to VET data to a range of stakeholders and researchers balanced against safeguarding the privacy or the confidentiality needs of an individual or an organisation, including registered training organisations (RTOs), that contributed information to the collection.

The Protocol is the decision of Ministers responsible for vocational education and training on this matter. For more information, refer to the <u>Australian Government Department of Employment and Workplace Relations</u> website.
