# **Government-funded students and courses -** January to September 2024 National Centre for Vocational Education Research



# Highlights

The number of students enrolled in government-funded nationally recognised qualifications in Australia between January and September 2024 increased by 4.3% to 995 090 compared with the same period in 2023, representing a 13.4% rise from the same period in 2019.

Compared with the same period in 2023, students enrolled:

• at TAFE institutes increased by 8.4% to 550 510 (up 10.2% from the same period in 2019)

• at other providers, such as Private and Community providers, remained steady at 462 015 (up 17.9% from the same period in 2019)

• in Certificate III or higher qualifications, grew 4.5% to 846 610 (up 15.7% from the same period in 2019).

Student numbers varied by cohort:


Note: Nationally recognised qualifications are comprised of training package qualifications and accredited qualifications. For comparison, 2019 (pre-COVID-19) data has been included.

The publication also includes data on students who undertook other forms of nationally recognised training, including training package skill sets, accredited courses, locally developed skill sets and courses, as well as stand-alone subjects. It also covers non-nationally recognised training, such as non-nationally recognised programs and subjects.

### **Students**

In the nine months ending 30 September 2024, 1 100 245 students were enrolled in government-funded VET in Australia, an increase of 2.4% from the same period in 2023.





Note: This chart shows the overall picture of Australia and does not update based on state/territory selection.

In the nine months ending 30 September 2024, 1 061 415 government-funded students were enrolled in nationally recognised VET, consisting of:

- training package qualifications (914 280 students or 86.1%)
- accredited qualifications (93 770 students or 8.8%)
- training package skill sets (13 060 students or 1.2%)
- accredited courses (41 940 students or 4.0%)

 locally developed skill sets and courses comprised of at least one nationally recognised subject (49 375 students or 4.7%)

• stand-alone nationally recognised subjects (15 805 students or 1.5%).

Note that students are enrolled in one or more programs, others in stand-alone subjects, and some in a combination of both.

Note: The sum of students will not add to the January to September 2024 total (1 061 415) for Australia as a student may have enrolled in multiple programs and/or subjects in the reporting period. Although locally developed skill sets and courses are not nationally recognised, associated training activity includes at least one nationally recognised subject.

In the nine months ending 30 September 2024, 59 570 government-funded students were enrolled in non-nationally recognised VET, consisting of:

- non-nationally recognised programs (31 030 students)
- higher education qualifications (70 students)
- stand-alone non-nationally recognised subjects (28 770 students).

## **Provider reporting type**

In the nine months ending 30 September 2024, 1 394 providers were delivering government-funded VET in Australia, unchanged from the same period in 2023.


Note: The total is a distinct count of training providers that submitted data through the state training authorities. Some training providers deliver VET in more than one state or territory and may be classified against multiple provider reporting type classifications, but only counted once in the total.

## Students by provider reporting type

Of the 1 100 245 students enrolled in government-funded VET in Australia:

- 605 455 or 55.0% were enrolled at TAFE institutes (up 7.1% from January to September 2023)
- 54 500 or 5.0% at other government providers (up 11.7%)
- 60 225 or 5.5% at community education providers (up 1.0%)
- 352 695 or 32.1% at private training providers (down 5.0%)
- 62 270 or 5.7% at other training providers (down 4.1%).

### **Program enrolments**


In the nine months ending 30 September 2024, there were 1 271 600 government-funded program enrolments in Australia, an increase of 2.1% from the same period in 2023. Of these:

• 87.9% were in qualifications, including training package qualifications (79.4%) and accredited qualifications (8.5%)

- 5.1% were in training package skill sets and accredited courses
- 4.4% were in locally developed programs comprised of at least one nationally recognised subject
- 2.6% were in non-nationally recognised programs.

In the nine months ending 30 September 2024, the most popular field of education was Engineering and related technologies (215 730 or 17.0%), followed by Society and culture (194 245 or 15.3%).

In the nine months ending 30 September 2024, there were 1 117 475 government-funded nationally recognised qualification enrolments in Australia (up 3.7% from the same period in 2023). The most popular level of education was Certificate III (551 830 or 49.4%), followed by Certificate IV (228 540 or 20.5%).





Figure 5 Government-funded nationally recognised qualification enrolments by level of education, January to September 2023 and 2024, Australia

In the nine months ending 30 September 2024, Community Services had the highest number of training package enrolments (240 255 or 23.7%), followed by Construction, Plumbing & Services Integrated Framework (103 570 or 10.2%).


# **Subject Enrolments**

In the nine months ending 30 September 2024, there were 9 125 690 enrolments in government-funded VET subjects across Australia.


Of these, 94 265 (1%) were in stand-alone subjects, consisting of:

- 35 850 nationally recognised subjects
- 58 420 non-nationally recognised subjects.
