AVETMISS reporting

USI transcript update tool

The USI transcript update tool is available for adding and/or updating 2023 AVETMISS activity.

This tool cannot be used for training that includes 2024 dates as this data must be reported via your normal reporting method.

Quarter 2 reporting

The collection window for Q2 2024 (covering the period January to June 2024) fee-for-service activity submissions direct to NCVER will be open from 1-14 August 2024.

If you submit your fee-for-service data via a State Training Authority (STA), please ensure you are aware of their submission dates.

AVETMISS Validation Software (AVS) User accounts

The biggest issue RTOs had this year during their annual AVETMISS reporting was access to AVS following a change of personnel and updating organisation or user details. Please note:

- AVS has been set up for RTOs to control who has access within their organisation. As RTO users with appropriate access are able to add and amend data directly to student USI transcripts, it is important to review access regularly and to deactivate anyone who has left your organisation.
- User email addresses cannot be updated within AVS. A new user needs to be created, and then the previous user and their email address can be deactivated.
- Whilst validations in AVS are checked against TGA, any updates made via ASQANet are not reflected in AVS - the systems are not linked. Details in AVS must be updated separately e.g., changes to CEO or legal/business names. However, you will still be able to submit data because the RTO number is used for reporting compliance purposes.
